REG REVIEW COURSE SCHEDULE FOR JUNE 2010

REG REVIEW and the Association of Environmental and Engineering Geologists are pleased to announce their Exam Review Courses for the Certification Exams for Engineering Geology (CEG) and Hydrogeology (CHG) for the October, 2010 exams. REG REVIEW's Certification exam courses this summer are on Saturday, June 12th in Southern California (in Santa Ana right near the Orange County airport) and on Sunday, June 13th in Oakland. At both locations the CEG course is being taught in the morning from 8am to 12:30pm and the CHG course is being taught in the afternoon from 1:30pm to 5pm.

The preregistration deadline for the Summer, 2010 REG REVIEW CEG and CHG courses is on May 21, 2010. This deadline is just after the application deadline (June 7, 2010). In order to obtain the preregistration rate, you must register online by May 21, 2010 or your registration form must be faxed or postmarked by/with that date. Registration is still available after the preregistration deadline but it incorporates a late fee of \$50. Register now to obtain the lower fee. At both locations the CEG course is being taught in the morning from 8am to 12:30pm and the CHG course is being taught in the afternoon from 1:30pm to 5pm.

The preregistration deadline for the Summer, 2010 REG REVIEW CEG and CHG courses is on May 21, 2010. This deadline is just after the application deadline (June 7, 2010). In order to obtain the preregistration rate, you must register online by May 21, 2010 or your registration form must be faxed or postmarked by/with that date. Registration is still available after the preregistration deadline but it incorporates a late fee of \$50. Register now to obtain the lower fee.

The CEG Course price is \$325 for AEG members, \$340 for nonmembers and includes the newly revised CEG Study Manual.

The CHG Course price is \$250 for AEG members, \$265 for nonmembers and includes the CHG Study Manual.

If you take both together the total cost is \$575 for AEG members, \$590 for nonmembers which includes both manuals.

If you bought the books earlier, there is a discount on the class depending on which class it is and which books you have. The discount is only for the original purchaser of the books and is applied and refunded after confirmation of prior purchase.

The statewide CEG pass rate for March, 2009 was 52% and for the CHG was 60%. March, 2007 results were CEG-46% and CHG-30%. We first reinstated the CEG/CHG courses in Fall of 2007 for the March, 2008 exams. Pass rates of our students is typically 20 to 25% higher than the average. This could explain

the higher pass rates beginning with the March, 2008 exams which occurred after our first class for the CEG/CHG exams in 8 years. Over the years since the inception of the Engineering Geology Certification Exam in 1970, the pass rate has varied from 15% to 84% passing with an average pass rate of 55%. The CHG exam began in 1995 and since that time the pass rate has varied from 30% to 82% passing with an average of 61%.

PLEASE NOTE: California only gives the CEG and CHG exams in October of each year. This coming October the exam will only be given in Southern California. **The deadline for filing applications for the October exams is June 7, 2010.** These exams will not have been given for 1 1/2 years, can you afford to wait any longer because you did not take advantage of what was available to help you pass?.

The time is now for acting on your application and thinking about studying.

REG Review, Inc. has been teaching courses for geological licensing in California since 1985. In November, 2000, we began to direct our teaching towards the ASBOG[®] geology licensing exam. In 2007, we reinstated the CEG and CHG Certification courses that we have taught since 1985 (the exams have not changed significantly since that time). The courses are taught by Patti Sutch, California PG 3949, CEG1641, and CHG 25, and Lisa Dirth, California PG 3951, CEG 1240, and North Carolina RG by ASBOG exam.
