Our October joint SDAG/AEG meeting at the Marina on October 8, 2009 had a full house with lots of members/non-members showing up for **Dr. Monte Marshall's** presentation on **"THE REALLY BIG PICTURE OF THE GEOLOGIC HISTORY OF SOUTHERN CALIFORNIA FROM 15 Ga TO THE CRETACEOUS! A Field Trip Primer"**.

**Dr. Marshall's** presentation was very interesting providing a synopsis of what to expect for the upcoming 2009 SDAG Annual geology field trip: Mylonitization and Associated Low Angle Faulting in the Southeastern San Jacinto and Northern Santa Rosa Mountains, California. The Annual field trip is occurring November 6<sup>th</sup> to 8<sup>th</sup>, 2009.

**Ms. Kim Taylor** (Geologist, Attorney) was unable to attend this meeting. She had limited time to prepare and file an important injunction against the implementation of AB20 4X regarding the abolishing of the California Board for Geologists and Geophysicists.

Kim was to provide details on what has been done thus far, who is involved and what we can contribute to this effort and what the status of the newly formed AEG Southern California (AEGSC)- Political Action Fund formed to prepare this injunction. This action may cost between \$15,000 and \$100,000 dollars the AWGSC-PAF is seeking donations to pay the legal fees for this injunction. **AEG Southern California Section Presents: Board for Professional Engineers and Land Surveyors Town Hall Meeting.**

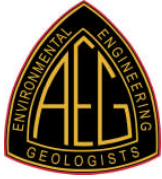
