

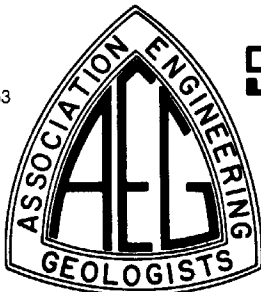

EG & G Idaho, Inc.

**TOPIC:** Mt. Borah Earthquake, Idaho

Scott plans to discuss some of the regional geologic features of central and southern Idaho, then narrow in on the subject fault zone by providing a pictorial tour of the area. He will discuss the seismological and geological data, and emphasize future studies and their relationship to the Idaho National Engineering Laboratory (INEL), a DOE (Dept. of Energy) facility.
