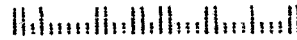
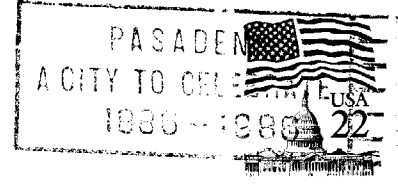

LONG BEACH, California (Guacci Press)-- It was reported this morning that the July 8 speaker will be JOSEPH W. COBARRUBIAS (City of Los Angeles, Department of Building and Safety), whose topic will be the FAIRFAX GAS INCURSION. Joe will present information relating the occurrence of the methane gas incursion and the subsequent explosion, fire, and injury to approximately 26 people, that took place in the Fairfax District in the spring of 1985. The city's response to this event was to establish a task force, chaired by the Department of Building and Safety, with technical committees to assist the task force investigation. The Fairfax District is situated over the old Salt Lake Oil Field, abandoned on or around the early 1900s, and subsequently urbanized. The gas was determined to be from natural sources emanating from a rather complex, near-surface groundwater regime. The attempt to a solution involved interpretation of geological factors and relating these to methane gas control systems as available.
