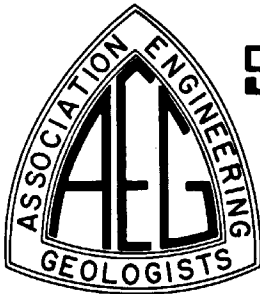

STATE MINING AND GEOLOGY BOARD PUBLIC HEARING

The State Mining and Geology Board invites all persons interested in the proposed amendments of its regulations in the State Policy for Surface Mining and Reclamation Practice to attend a public hearing at 10:00am on Wednesday, February 16, 1983. The hearing will be held in Suite 300 of the Solid Waste Management Board Office, 1020 9th Street, Sacramento, California. An initial statement of reasons and the full text of the proposed amendments is available. Following the hearing, the Board may adopt the proposed amendments without further notice. Oral and/or written statements or contentions relevant to the proposed action at the hearing are welcome. Requests to make oral presentations and filing of written statements should be directed to the Board's Sacramento office by February 9, 1983.

STATE MINING AND GEOLOGY BOARD RECLAMATION PLANNING GUIDE

The S.M.G.B. has released draft #5 of the proposed Reclamation Planning Guide. The guide is intended to assist both mine operators and lead agencies in complying with the reclamation provisions of the Surface Mining and Reclamation Act. The Guide will replace the Model Reclamation Plan now found in California's Administrative Code. AEG UTAH SECTION FIELD TRIP

JEFF KEATON sends his regards to the Southern California Section along with the following announcement. The Utah Section of AEG is organizing a 3-day field trip to the St. George area of southern Utah, tentatively scheduled for Saturday, Feb. 19 - Monday, Feb. 21. The trip would leave Saturday morning from Salt Lake City, stopping to look at hydrocompaction problems in Cedar City and the proposed Quail Creek damsite near Harrisburg. Sunday would involve the general geology and engineering geology of the St. George area, including the Virgin anticline and problems caused by steep dips, inverted topography resulting from basalt flows in stream channels, slope stability problems in the Moenkopi and Chinle formations, and Quaternary faulting along the Washington fault. We would return to Salt Lake City on Monday. The trip would require lodging for two nights in St. George. Transportation would be by caravan of privately-owned vehicles or by rental van. The Board has adopted amended regulation 3005 which adds a fee for the Engineering Geology application. In addition a new policy memorandum (82-1) was released pertaining to Engineering Geology Certification, fees, and application procedures.

NEWS OF MEMBERS

DR. JAMES E. SLOSSON served as a technical expert for the Federal Emergency Management Agency at a three-day meeting in December at the Los Angeles County Flood Control District. Purpose of the meeting was to resolve the technical problems that remain prior to authorization by the Agency relating to production of the approximate mud flood and mudflow hazard maps as well as approval of the detailed mapping methodology. The panel consisted of representative technical experts from the United States Geological Survey, United States Forest Service, California Department of Water Resources, California Division of Mines and Geology, and the County of Los Angeles. Included in the session was a helicopter flight over the critical areas of the county.

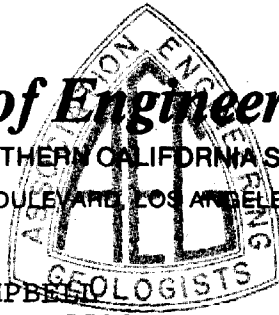


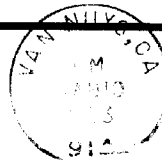
